Workshop Agenda

- Gurgaon's electricity need is rising steeply. About 50 per cent of this need is met through polluting and high-price diesel.
- With large buildings and enough number of sunny days, Gurgaon is ideally placed to exploit the goodness of solar. The new solar policy by the Haryana government announced in September 2014 is a step in the right direction. Following this policy, the state has also made it mandatory for all buildings of 500 square yards or more to install rooftop solar power systems by September 15, 2014. Besides, the Ministry of Non-Conventional Energy Sources (MNES) has recently granted subsidy a 15 per cent subsidy for setting upto 5 MW solar power generation in the state.
- The policy is a wonderful opportunity for Gurgaon's households, condominiums, office buildings, hospitals, hotels, malls, schools, colleges and institutions to adopt solar. These buildings can not only reduce their dependence on grid power and diesel, the adoption can also help reduce electricity bills over time. Besides, Solar Power is Clean Energy.
- However, the end user needs clarity. Clarity is needed on the policy and the mandatory order. Users need understanding on players, pricing and various options for putting up solar. Also, they would need to know if additional revenues could be made by selling solar power to the grid.
- This workshop will aim toward bringing clarity on HAREDA's policy and help improve understanding by various end users about the new opportunity. This will facilitate adoption of solar power in Gurgaon. The workshop will bring together HAREDA, MNES, HERC, DHBVNL, solar players, solar experts as well potential users including RWAs, Industry, NGOs, Citizen Groups, schools and other institutions.

Key Questions before the Workshop

Key questions that the workshop will aim to address are:

- What exactly is the new solar policy by the Haryana Government and how does it aim to encourage solar?
- What are the incentives to switch to solar by way of subsidy etc both by the state and the centre? What is the priority basis for subsidy?
- What is the role of the state electricity regulatory agency and the state power utility?
- When can net metering be operationalised so that surplus power can be sold to the grid?
- What are the various options (players, pricing, technology) to switch to solar?
- What are the other options available, including financing schemes, third party ownership etc?
